

## LOGIX FEDERAL CREDIT UNION

### “SPOT THE BOT” DIGITAL TOOLS SCAVENGER HUNT SWEEPSTAKES

#### OFFICIAL RULES

- 1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**
- 2. EACH SWEEPSTAKES ENTRY WILL HAVE AN EQUAL CHANCE OF WINNING. MAKING A PURCHASE WILL NOT IMPROVE AN INDIVIDUAL ENTRY’S CHANCES OF WINNING.**
- 3. Sweepstakes Period:** Sweepstakes begins Wednesday, May 24, 2023 at 12:00 a.m. PDT and ends Wednesday, May 31, 2023 at 11:59 a.m. PDT (“Sweepstakes Period”).
- 4. Consumer Disclosure:** Odds of winning are based upon the number of entries received. Based upon Logix Federal Credit Union’s estimate of 30,000 entries, the odds of winning are 9:30,000
- 5. Prizes:** Eight (8) randomly selected daily winners of \$500 cash prize and one (1) randomly selected grand prize winner of \$1,000 cash prize deposited into your Logix savings account.
- 6. Sponsor:** Logix Federal Credit Union “Logix” is the sponsor of the Sweepstakes. Logix Federal Credit Union’s business address is 27918 Franklin Parkway, Valencia, California, 91355.
- 7. Entry Deadline:** To be eligible, entries must be submitted by 11:59 a.m. PDT, Wednesday, May 31, 2023.
- 8. Eligibility:** To be eligible for the Sweepstakes all entrants must be at least 18 years of age and a member in good standing at the time of prize drawing. Logix employees, officials, directors, and members of their immediate families are not eligible to participate in the Sweepstakes. By entering this Sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of Logix. Sweepstakes void where prohibited by law.
- 9. How to Enter:** Eligible individuals who “Spot the Bot” and click on the graphic to complete and submit the Sweepstakes Entry Form, which consists of full name, email address, and confirmation of membership, will receive one (1) entry into the Sweepstakes. One (1) entry is allowed per member, per each Logix digital tools page and digital communication. Multiple submissions through the same digital tools page and digital communication will not result in multiple entries to the Sweepstakes. The “Spot the Bot” is a clickable graphic of Max the dog (The Logix Mascot’s Robot Dog) wagging his tail and can be found on various Logix digital tools pages, including but not limited to Mobile App, Digital Wallet, MoneyMover, Financial Calculators, and eStatements, as well as digital communications, including but not limited to blogs and email communications.

Entries using macro, robotic, script or other forms of automatic entry will be disqualified. Proof of submission does not constitute proof of receipt. The Credit Union is not responsible for late,

incomplete, or inaccurate entries. If there is a dispute as to the identity of an on-line entrant, the prize will be awarded to the authorized account holder of the e-mail address linked to the applicable entry. The “authorized account holder” is defined as the natural person to whom the e-mail address is assigned by an internet service provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. The Credit Union is not responsible for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by the Credit Union on account of technical problems or traffic congestion on the Internet or at any Website or any combination thereof. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, the Credit Union reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. The Credit Union reserves the right to select winners from eligible entries received as of such termination date. The Credit Union further reserves the right to disqualify any individual who tampers with the entry process. The Credit Union may prohibit an entrant from participating in the Sweepstakes if it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception or other unfair practices or intending to abuse, threaten or harass other entrants.

10. **Prize Drawing:** The daily eight (8) random \$500 cash prize drawings and one (1) random \$1,000 cash grand prize drawing will be held, as follows:

All drawings will be held at Logix Headquarters located at 27918 Franklin Pkwy., Valencia, CA 91355. In the event the prize drawing falls on a federal holiday, the prize drawing will be held on the next business day. The winners need not be present and will be notified by phone, e-mail, and/or mail by 3:00 p.m. on the day of the drawing. The prizewinner must claim prize by 5:00 p.m. on Monday, June 5, 2023. The winner must reply to Logix in order to claim the prize. If the winner does not reply to Logix to claim the prize by the time and date noted above the prize will be forfeited and the prize that is not claimed during the redemption period becomes property of the Credit Union. Limit one (1) Prize per person/family/household for the entire Sweepstakes Period.

Cash funds will be deposited in the winner's savings account by 5:00pm on Friday, June 9, 2023.

The prizewinner will be required to complete a Winner Affidavit of Eligibility, Liability & Publicity Release Agreement and return same, properly executed, prior to collecting the prize. Failure to return signed Winner Affidavit of Eligibility; Liability & Publicity Release Agreement will result in forfeiture of prize.

11. **LIMITATION OF LIABILITY:** The Credit Union is not responsible for any loss or damage which may occur in connection with the Sweepstakes. Entrant agrees to hold the Credit Union harmless from any liability arising from participation in the Sweepstakes or the acceptance, use, misuse, or possession of any prize received in this Sweepstakes. The Credit Union and each of its officers, directors, employees, members, representatives and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance, use, misuse, or possession of any prize awarded or participation in this Sweepstakes. The Credit Union is not responsible for any incorrect or inaccurate information, whether caused by tampering, hacking, or by any of the equipment or programming associated with the Sweepstakes. The Credit Union reserves the right to substitute a prize of equal or greater value should the featured prize(s) become unavailable for any reason. The Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the Sweepstakes and redemption of a prize.
12. **LIST OF WINNERS:** For disclosure of the winner, mail a self-addressed, stamped envelope to Logix Federal Credit Union, Attention: "Spot the Bot" Digital Tools Scavenger Hunt Sweepstakes, 27918 Franklin Parkway, Valencia, CA 91355. Request must be received by Monday, July 31, 2023.
13. **TAXES:** The Credit Union will report all prize winnings to the appropriate state and federal agencies as required by applicable law. Winner is responsible for all tax consequences (if any) of the prizes.
14. **PUBLICITY AUTHORIZATION:** The winner agrees to permit the Credit Union to utilize his/her name and likeness in promotional and other Credit Union materials, without additional compensation or permission, except where prohibited by law.
15. **CHOICE OF LAW:** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and the Credit Union in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the State of California, USA, without regard to choice of law rules.
16. **ARBITRATION: NOTICE OF BINDING ARBITRATION AGREEMENT:** In this section, "you" refers to Entrant. You and Logix agree to attempt to informally settle any disputes arising out of or connected with this Sweepstakes or any prizes awarded. If that cannot be done, you and Logix agree that upon the election of either you or Logix any claim or dispute arising out of or connected with this Sweepstakes will be resolved by **BINDING ARBITRATION** administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules and Mediation Procedures and Supplementary Procedures for Consumer-Related Disputes

("Rules"). As a result, you will GIVE UP YOUR RIGHT TO GO TO COURT to assert or defend your rights under these Official Rules (EXCEPT FOR CLAIMS BROUGHT INDIVIDUALLY WITHIN SMALL CLAIMS COURT JURISDICTION, SO LONG AS THE CLAIM REMAINS IN SMALL CLAIMS COURT). You acknowledge that by agreeing to **BINDING ARBITRATION** you understand and agree to the following terms:

(a) Your rights will be determined by a NEUTRAL ARBITRATOR and NOT a judge or jury. You understand and agree that **YOU ARE WAIVING THE RIGHT TO A TRIAL BY JURY.**

(b) Arbitration proceedings provide you a **FAIR HEARING**, BUT the arbitration procedures are **SIMPLER AND MORE LIMITED** THAN RULES APPLICABLE IN COURT.

(c) Any claims and defenses that can be asserted in court can be asserted through arbitration. The arbitrator shall be entitled to award the same remedies that a court can award, including **PUBLIC INJUNCTIVE RELIEF** to the extent available under the **CALIFORNIA UNFAIR COMPETITION LAW AND CONSUMER LEGAL REMEDIES ACT.** Discovery shall be available for non-privileged information to the fullest extent permitted under the Rules. The arbitrator's award can be entered as a judgment in court.

(d) Arbitration decisions are as enforceable as any court order and are subject to **VERY LIMITED REVIEW** BY A COURT.

(e) ARBITRATORS can award the same REMEDIES including DAMAGES that a COURT can award.

(f) Any ARBITRATION under these Official Rules **WILL BE ON AN INDIVIDUAL BASIS.** You understand and agree that **YOU ARE WAIVING THE RIGHT TO PARTICIPATE AS A CLASS REPRESENTATIVE OR CLASS MEMBER IN A CLASS ACTION.**

(g) The PLACE OF ARBITRATION shall be in the federal district WHERE YOU RESIDE.

(h) This **NOTICE OF BINDING ARBITRATION AGREEMENT** shall be interpreted and enforced in accordance with the Federal Arbitration Act set forth in Title 9 of the U.S. Code to the fullest extent possible, notwithstanding any state law to the contrary, regardless of the origin or nature of the claims at issue.

(i) If YOU PREVAIL on the merits of your claim in arbitration, LOGIX WILL PAY YOUR ATTORNEYS' FEES. You will NOT be required to pay LOGIX'S ATTORNEYS' FEES IF LOGIX PREVAILS.
